

Evaluation Committee therefore recommends Bidder No. 32. K K Target Trading cc amounting to **N\$ 109 480.10** to be the first lowest responsive bidder. Bidder No. 36. Tesla's Cleaning Supplies cc is the second lowest responsive bidder amounting to **N\$ 108 336.51**.
