1. Conclusion

The evaluation committee recommended that LOT1 be awarded to **GNT INVESTMENT CC** for an amount of **N\$ 32,810.14**. Lot 2 is non-responsive. The BEC recommend award of LOT 3 to GNT Investments cc for an amount of **N\$ 30,876.32**. LOT 4 is recommended for GNT Investments for an amount of **N\$ 20,901.89**. LOT 5 is non-responsive while LOT 6 is recommended to MBISHI Investment cc for an amount of **N\$ 67,612.94**. **BEC finally recommend award of LOT 7 to MBISHI investment cc for an amount of N\$ 32,048.76.**
