### SECTION I: INSTRUCTIONS TO BIDDERS

#### 1. Rights of Public Entity

The Kunene Regional Council reserves the right:

- (a) to split the contract as per the lowest evaluated cost per item, or
- (b) to accept or reject any quotation; and
- (c) to cancel the quotation process and reject all quotations at any time prior to contract award.

#### 2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

- (a) the Quotation Letter with its annex for Bid Security
- (b) the List of Goods and Price Schedule;
- (c) the Specifications and Compliance Sheet in Section V; and
- (d) any other attachment deemed appropriate.

You are advised to carefully read the complete Request for Sealed Quotations document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

#### 3. Validity of Quotations

The Quotation validity period shall be **180** days from the date of submission deadline.

#### 4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should:

- a) Have a valid certified copy (NAMPOL) of company Registration Certificate;
- b) Have a valid certified copy (NAMPOL) of good Standing Tax Certificate;
- c) Have a valid certified copy (NAMPOL) of copy good Standing Social Security Certificate:
- d) Have a valid certified copy (NAMPOL) of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998;
- e) Have a valid certified copy (NAMPOL) certificate indicating SME Status (for Bids reserved for SMEs);
- f) Submit signed Bid-securing Declaration.

- g) Attach two references e.g copy of purchase order or reference letter from reputable companies, agencies and Ministries confirming previous success delivery of IT equipment.
- h) Attached proof of confirmation of account from a Namibian Banking Institution (only successful bidder to furnish after award of contract)

#### 5. Bid Securing Declaration

#### 6. Delivery

Delivery shall be 30 days after acceptance of award and signing of contract. Deviation in delivery period must be communicated.

#### 7. Sealing and Marking of Quotations

Quotations should be sealed in a single envelope, clearly marked with the Procurement Reference Number, addressed to the Public Entity with the Bidder's name and contact information at the back of the envelope.

#### 8. Submission of Quotations

Quotations should be deposited in the Quotation/Bid Box located at Kunene Regional Council, Mbumbijazo Muharukua Street, and Private bag 502, Opuwo not later than **17 September 2025 at 11h00**. Quotations by post or hand delivered should reach Kunene Regional Council 17 September 2025 at 11h00 at latest. Late quotations will be rejected.

Quotations received by e-mail or faxed will not be considered.

#### 9. Opening of Quotations

Quotations will be opened by members of Procurement Management Committee at the Kunene Regional Council immediately after the closing time referred to in instruction 7 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of a Bid Security will be posted on the website of the Kunene Regional Council and available to any bidder on request within three working days of the Opening.

#### 10. Evaluation of Quotations

The Kunene Regional Council shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.

#### 11. Technical Compliance

Bidders shall submit along with their quotations documents and any other literature to substantiate compliance with the required specifications and to qualify deviations if any with respect to Kunene Regional Council requirements.

The Specifications, Performance Requirements and Compliance Sheet details the minimum specifications of the goods/items to be supplied. The specifications have to be met but no credit will be given for exceeding the specifications.
