The Kunene Regional Council has successfully established its Independent Audit Committee since its existence. The Audit Committee today, 08 February 2021 has assembled for an introductory meeting with Management Cadres to get an overview of the Regional Council's operations in the past years.

The first committee meeting focused on the recommendations made from the Office of the Auditors General in the past years, a report of the 2019/20 financial statement and recommendations on the current 2020/21 financial statement that is yet to be submitted to the Office of the Auditor General.

The committee gave a brief introduction on its purpose, the value it will to add to the institution and measures to ensuring reliable reporting and timey submission of financial statements.
