#### **i. Legal Admissibility Evaluation Grid**

After verifying the submitted documentary evidence establishing the Bidder's legal qualification the Evaluation Committee has concluded that all Seventy four (74) bids can be considered in the further evaluation and comparison procedure:

From all seventy-four (74) responsive bids some bidders have submitted for all 14 zones and some just specific zones, for provision of municipal services in Kunene Regional Council at various GRN offices within the region.

#### **ii. Technical Admissibility**

Before awarding, the Committee will assess the technical capability of the bidders

This will be done by requesting the bidder to present Vehicle, Trailer, Tank and Sewerage Pump closes town from their zone of operation.

#### **iii. Financial Admissibility Evaluation Grid**

Price Preferences 5% were applied to all the bidders with proof of Residence Letter from the Regional Councilors.

District Factor were also applied percentage wise (2,3 & 5% respectively) away (kilometers travel to provide municipal services) from home base to site (see Evaluation Criteria – 1. Evaluation)

SEE ANNEXURE B for Zone 1-14. These percentages are added as indicated in evaluation criteria to put a bidder in close proximity to the site in most favourable position and to the benefit of both government as well as the contractor (bidder) effective response as well as reduce logistical challenges. We could not achieve the aforementioned throughout(various) but the bid prices submitted for the all the zones are best evaluated responsive amounts.

The rates applied for labour component (Driver and Labourer rates) were taken from Collective Agreement Gazette (Substantive Agreement on Minimum Wages and conditions) by Ministry of Labour, Industrial Relations and Employment Creation. Government Gazette No 7600, Notice No 165.

This agreement is for two (2) years that is, starting from date of Promulgation (12 August 2021). The first year of the agreement has ended 11 August 2022 and the Second (2) year Started 12 August 2022. Therefor this bid has been issued on the 29 August 2022 (meaning second year) and so the adjusted rates applied. Thus the bidders that submitted first year (1) rates were not considered.

Labour rates were applied as follows:

Driver

Light Vehicle – with B or BE license N\$25.33

Heavy Vehicle – with C, C1 or C1E N\$ 30.02

Labourer – 17.83

The Ad hoc Evaluation Committee therefor make an Interval for best rate to be from N\$ 25.33 to N\$ 34.52(includes 15% mark up) and for Labourer N\$ 17.83 – N\$ 20.50 (includes 15% mark up). All the rates within abovementioned intervals were considered for evaluation and recommendation.


