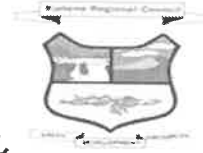

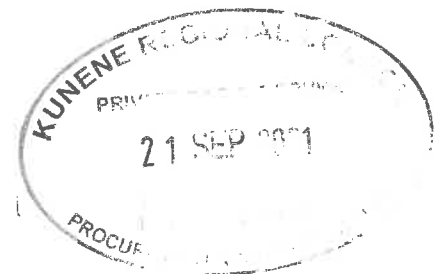

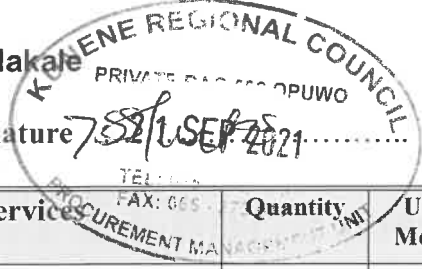

1. Employer

- a. The Kunene Regional Council inviting the Informal Quotation is the Employer for the purpose of entering into contract with the successful bidder.

2. Service Provider

- a. The bidder having submitted the lowest price and whose offer is substantially responsive to the requirements specified shall be selected for award and referred to as the Service Provider.

3. Rights of Public Entity

- a. The Kunene Regional Council shall have the rights to
 - (a) Ask for clarifications at time of evaluating quotations and
 - (b) Reject all quotations.
- b. A Public Entity shall not be bound to accept the lowest or any quotation.

4. Eligibility Criteria

5. To be eligible to participate in this Quotation exercise, you should:
 - a) have a valid certified copy of company Registration Certificate
 - b) have an original valid good Standing Tax Certificate;
 - c) have an original valid good Standing Social Security Certificate;
 - d) have a valid certified copy of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998;
 - e) have a certificate indicating SME Status (for Bids reserved for SMEs);
 - f) An undertaking on the part of the Bidder that the salaries and wages payable to its personnel in respect of this proposal are compliant to the relevant laws, Remuneration Order, and Award, where applicable and that it will abide to sub-clause 4.6 of the General conditions of Contract if it is awarded the contract or part thereof; and;
 - g) Attach proof of confirmation account from Namibian Banking Institution.
 - h) Bidders are required complete the local sourcing declaration form.
 - i) Preference shall be given to local bidders from Kunene Region where the service is required. Therefore, attach a confirmation letter from the Councilor's Office not older than 2 months.
